

### Investment Objective

The Global Beta Rising Stars ETF seeks to track the performance (before fees and expenses) of the FactSet Rising Stars Index. The index is composed of stocks listed on the NYSE and Nasdaq that demonstrate the largest expansion of market share in the fastest growing technology industries with better relative valuations than their peers.

### Strategy

The FactSet Rising Stars strategy first navigates the top 3000 securities by market capitalization that are listed on the NYSE and Nasdaq exchanges and vets them for liquidity standards. Next, we look at the securities recent year over year revenue growth rate vs the average annual revenue growth rate they need to achieve over the next decade to justify their current price-to-sales ratios. We then look at the market share growth rate each company has demonstrated year over year within each subindustry, according to “RBICS” classifications, in technology. We then look at the growth rate for each subindustry as a whole for which each company participates in. Lastly, we look at each company’s year over year growth rate of their operating margins. We score each company by each aforementioned pillar, based on those growth rates. The top 100 are selected into the final index and are weighted by those scores relative to each other.

### Screening Process



#### STEP 1

Starts with US exchange listed securities, vetted for liquidity standards. Next, we screen out companies we believe are overvalued, and then identify companies that are growing their market share in the fastest growing technology industries.



#### STEP 2

We score each company by each aforementioned pillar, based on those growth rates.



#### STEP 3

The top 100 are selected into the final index and are weighted by those scores relative to each other. The index is rebalanced quarterly.


Effective December 21, 2020, the Fund’s underlying index was changed from the Global Beta Momentum-Growth Factor Index (“Former Target Index”) to the FactSet Rising Stars Index (“Target Index”). Thus, Fund performance shown above prior to December 21, 2020 reflects the Fund seeking to track the performance of the Former Target Index and Fund performance shown above beginning December 21, 2020 reflects the Fund seeking to track the performance of the Target Index. Effective December 21, 2020, in connection with the change of the Fund’s underlying index, the Fund’s broad-based securities market benchmark index for performance comparison purposes was changed from the S&P 500 Index to the S&P 1500 Index.

The Blended - FactSet Rising Stars Index performance information reflects the blended performance of the Global Beta Momentum-Growth Factor Index through December 20, 2020 and the FactSet Rising Stars Index thereafter.

The Former Target Index was comprised of equity securities of U.S. companies from the S&P 500 in the highest quintile (i.e., the highest 20% of the S&P 500) based on their year-over-year revenue growth rate, as measured by their most recently reported quarterly revenue as compared to the quarterly revenue reported four quarters ago.
